VENDOR GUIDELINES

Vendors participate in the Earth Day Festival by setting up a booth for the public to explore and enjoy. As a vendor, you must agree that you understand each of the guidelines below by checking them:

- Interactive Exhibit** - We require your site to be interactive! Hands-on activities, demos, games, and exhibits will engage participants and give Earth Day the profound punch it needs!
- Tables & Chairs** - Vendors **MUST** provide their OWN tables and chairs
- Canopy** - Vendors **MUST** provide a 10'x10' pop-up canopy for your site! All tents **MUST** be weighted and/or staked down. Be prepared for WIND!
- Generators** - Limited to our licensed food vendors **ONLY**
- Merchandise** - Vendors may sell items related in some way to the Earth Day message of conservation and sustainability.
- Green Event** - This is a certified green event so all exhibitors may not give/sell styrofoam, plastic straws, or balloons. all recyclable materials should be recycled. Please limit flyers and handouts that increase waste.
- Set-Up** - Begins at 8:30am. Every vendor **MUST** be in place and ready at 10:30am. No vehicles will be allowed on the field after 10:30am. Event starts at 11am / ends at 5pm.
- Parking** - Weather permitting, you will be allowed to drive up to your booth site to drop off supplies before 10:30am. Vendor vehicles will be parked in designated vendor parking.
- Vendor Meetings** - Every vendor **MUST** send a representative to **ONE** of the two offered vendor meetings leading up to the event. Vendor Meetings are scheduled for **Tuesday, April 15 at 10am OR 6:30pm** at the Dorothy Hart Community Center.
- Application** - Event Organizers reserve the right to accept/deny your application. You will be notified via email within 2 weeks of submission.
